## **Privacy Policy**

Acreage Holdings, Inc. and its affiliates (hereinafter referred to as "Acreage" "us," "we," "our," or "Company") have created the following Privacy Policy for when you visit our website at <u>www.acreageholdings.com</u> ("Website") and any other services where this Privacy Policy is posted (collectively, our "Services"). This Privacy Policy describes, among other things, how Acreage collects and uses your information when visiting our Website or using our Services. By using our Services, you consent to this Privacy Policy and to the changes posted here from time to time.

This Privacy Policy does not apply to information collected or obtained by any third party, including through any application or content that may link to or be accessible from or on the Services. This Privacy Policy is integrated into our <u>Terms and Conditions of Use</u>, which is also available on our Website. If there are any inconsistencies between our Privacy Policy and the Terms and Conditions of Use, the Privacy Policy controls.

If you are a California resident, please see Section VIII below for your California privacy rights, which supplements the Privacy Policy as to California Residents only.

## I. INFORMATION WE COLLECT ABOUT YOU

In order to access our Services or to respond to specific inquiries, Acreage may collect the following types of information: (A) Information You Provide to Us, (B) Information We Automatically Collect, (C) Information We Receive from Third Parties. All of the information listed in (A)-(C) above, are detailed below, and hereinafter to as "Information."

#### A. Information You Provide to Us

In using our Services, you may provide us with information, including, without limitation

- First and Last Name;
- Email;
- Unique identifier and password if you choose to create an account;
- Age Verification;
- Zip Code.
- IP Address

#### **B.** Information We Automatically Collect

Acreage also collects Information about you from your visit to our Services including:

- IP address, which is the number associated with the service through which you access the Internet, like your ISP (Internet service provider), your company, or your university;
- Your geographic location and time zone;
- Your response to the age verification request;
- Date and time of your visit;
- Your device, type of computer, web browsers, search engine used, operating system, or platform you use or web browser;

- "Cookies" are small digital files that are transferred to your computer or smartphone's hard drive when you visit a website or click on a URL. Cookies allow us to operate and personalize the Services, assist with functionality of the Website, to track your usage, and to deliver targeted advertisements to you. "Cookies are not linked to your name or address. Once you close your Web browser, the Cookie terminates. If you reject the Cookie, you may still use the Services.
  - Most web browsers automatically accept cookies unless you have configured yours not to accept them. You can program your browser not to accept cookies, but if you do, you may not be able to use certain portions of the Services and the Website will not be able to customize certain functions according to your preferences.
  - Cookies are placed on the Services, but executed by third parties such as Google, Bing, Facebook, and other ad networks. #### **D. Information We May Receive from Third Parties**

We may collect additional Information about you from third-party websites, social media platforms, such as, but not limited to Facebook and Instagram ("Social Media Platforms"), and/or sources providing publicly available information (e.g., from the U.S. Postal Service) to help us provide services to you, help prevent fraud, and for marketing and advertising purposes.

Information we may access about you, with your consent, may include, but is not limited to, your basic Social Media Platform information, your location data, your list of contacts, friends or followers and certain information about your activities on the Social Media Platform. Please keep in mind that when you provide Information to us on a third-party website or platform, the Information you provide may be separately collected by the third-party website or the Social Media Platform.

The Information we collect is covered by this Privacy Policy, and the Information the third-party website or Social Media Platform collects is subject to the third-party website or platform's privacy policies. ## **II. HOW WE USE YOUR INFORMATION**

### A. Use and Purpose of Processing Your Information

We use and process your Information for things that may include, but are not limited to, the following:

- To provide you with the Services and related products, promotions, newsletters, and information you request;
- To process transactions you make through or in connection with the Services;
- To respond to your inquiries and provide you with requested information and other communications, including by email or text messages, and including alerts, notification of promotions, contests, and events;

#### **B. Sharing Your Information**

We may share your Information as set forth in the Privacy Policy and in the following circumstances:

- Third-Party Service Providers. We may share your Information with third-party service providers that perform certain functions or services on our behalf (such as to host the Services, fulfill orders, provide products and services, manage databases, perform analyses, process credit card payments, provide customer service, or send communications for us). These third-party service providers are authorized to use your Information only as necessary to provide these services to us. In some instances, we may aggregate Information we collect so third parties do not have access to your Information to identify you individually.
- **Disclosure of Information for Legal and Administrative Reasons.** We may disclose your Information without notice: (i) when required by law or to comply with a court order, subpoena, search warrant, or other legal process; (ii) to cooperate or undertake an internal or external investigation or audit; (iii) to comply with legal, regulatory or administrative requirements of governmental authorities (including, without limitation, requests from the governmental agency authorities to view your Information); (iv) to protect and defend the rights, property or safety of us, our subsidiaries and affiliates and any of their officers, directors, employees, attorneys, agents, contractors and partners, and the Service users; (v) to enforce or apply our Terms & Conditions; and (vi) to verify the identity of the user of our Services.

- Information Shared with our Subsidiaries and Affiliates. We may share your Information with our subsidiaries and affiliates. We will retain your Information for as long as needed to provide you Services. You shall have the right to request that the information described above be provided to you in a portable and readily useable format, to the extent technically feasible ("data portability").

Acreage does not sell your Information.

### **B.** Deletion Request Rights

You have the right to request that Acreage delete certain of your Information that Acreage collected from and/or related to you and retained, subject to certain exceptions.

To the extent that Acreage can delete your Information, once Acreage receives and confirms your verifiable request, Acreage will delete (and direct our service providers to delete) your Information, unless an exception applies.

We may deny your deletion request if retaining the information is necessary for us or our service providers to:

- Complete the transaction for which we collected your Information, provide a good or service that you requested, or take actions reasonably anticipated within the context of our ongoing business relationship with you.
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity, or prosecute those responsible for such activities.
- Debug products to identify and repair errors that impair existing intended functionality.
- Exercise free speech, enable the right of another consumer to exercise their free speech rights, or exercise another right provided for by law.
- Comply with the California Electronic Communications Privacy Act (Cal. Penal Code § 1546 seq.).
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when the Information's deletion may

likely render impossible or seriously impair the research's achievement, if you previously provided informed consent.

- Enable solely internal uses that are reasonably aligned with consumer expectations based on your relationship with us.
- Comply with a legal obligation.
- Make other internal and lawful uses of that information that are compatible with the context in which you provided it.

### C. Exercising Your Access, Data Portability, and Deletion Rights

Only you or a person registered with the California Secretary of State that you authorize to act on your behalf, may make a verifiable request related to your Information. You may also make a verifiable request on behalf of your minor child.

You may only make a verifiable request for access or data portability twice within a 12-month period. The verifiable request must:

- Provide sufficient information that allows Acreage to reasonably verify you are the person about whom Acreage collected Information or an authorized representative.
- Describe your request with sufficient detail that allows Acreage to properly understand, evaluate, and respond to it.

### **D.** Non-Discrimination

We may not, and will not, treat you differently because you of your request activity. As a result of your request activity, we may not and will not deny goods or services to you, charge different rates for goods or services, provide a different level quality of goods or services, or suggest any of the preceding will occur. However, we can and may charge you a different rate, or provide a different level of quality, if the difference is reasonably related to the value provided by your Information.

### **E. Verifying Requests**

To help protect your privacy and maintain security, if you request access to or deletion of your Information, we will take steps and may require you to provide certain information to verify your identity before granting you access to your Information or complying with your request. In addition, if you ask us to provide you with specific pieces of Information, we may require you to sign a declaration under penalty of perjury that you are the consumer whose Information is the subject of the request.
